General Terms and Conditions

Quotations (RFQ) are invited from the Indian national agency/firms for Rain Water Harvesting Pit at IIML-NC.

Scope of Work:

Agency/Firm has to do work for Rain water harvesting pit cleaning at IIM Lucknow Noida Campus.

The scope of work includes rain water harvesting pit cleaning works. Following work shall have to be carried out by the contractor in the prices / rates offered by him:

- A. The work includes Rain Water Harvesting works as per the items indicated in the BOQ requirement / Relevant I.S./ to the satisfaction of the Engineer in charge including Rain Water Harvesting Pit at IIML-NC. whatever required to complete the work in all aspect.
- B. The rates Quoted includes all material, Labor costs, Transportation loading, storage, unloading cost whatsoever involved in completion of the work in all aspect.
- C. The work should be completed to the satisfaction of the Engineer in charge.
- D. Receiving of satisfactory completion of respective work as per the Institute format must be obtained by the Contractor before making any claim for such work.
- E. Defect liability period is 1 year from the date of completion of all the works stipulated in BOQ/ price bid. Any defect arising in respect to the works shall be rectified by the contractor at his own cost without any claim for labour, material, transportation cost whatsoever.
- F. Contractor shall maintain proper housekeeping during the works and should remove all the debris/waste/damaged/ un used material after completion of respective work.
- G. All the material used/make as per BOQ or as instructed by the Engineer In charge.
- H. All the Debris/ Malba etc. left after completion of the work shall be disposed off outside the campus on their own risk and cost.

ELIGIBILITY CRITERIA

- ➤ The bidder must have Registration Number of the bidder's firm i.e., GSTIN and the PAN number allotted by the concerned authorities.
- ➤ Having minimum one-year work experience in the rain water harvesting related works.
- ➤ Have completed construction/ recharging of rain water harvesting pit in any reputed institute/ organization (completion certificate must be attached).
- > Should have its own Office in Delhi & NCR.

TERMS AND CONDITIONS: - The bidder must ensure:

- 1. **Site Inspection:** Tenderer are requested to inspect the site before filling the Tender Documents. He/She must clarify all doubts regarding the nature of work, if any, before submission of the Tender Document. In this matter the Estate Office could be contacted on telephone No. 0120-6678532 for the purpose and any assistance in this regard.
- 2. Tenders not properly filled, mutilated, with incorrect calculations or generally not complying with the conditions are liable to be rejected. Tenderers should quote their rates both in figures and in words. All pages and enclosures are to be serially numbered

- 3. **Alterations in Tender Documents:** No alterations shall be made by the tenderer in any of the tender document, and if any alternations are made or any special condition attached, the tender is liable to be rejected.
- 4. **Acceptance of Tender:** The Institute does not bound to accept the lowest tender. The Institute also reserves the right to reject any or all the tenders, without assigning any reason(s).
- 5. **Payments:** The payment shall be released only after the satisfactory completion of the entire scope of work and verification by the Engineer-in-Charge / Estate Office. Additionally, 15% of the total contract value shall be retained and released only after the successful completion of the scheduled follow-up cleaning to be conducted after six months the initial work completion.
- 6. **Procurement Rights:** IIM Lucknow Noida Campus Reserves the right to curtail, enhance, conclude the quantity with entire or partial as mentioned in the RFQ.
- 7. The firm registered with NSIC/MSME should attach VALID document regarding exemption of EMD. Further in that case the firm may be exempted from depositing only EMD but in case of awarding the contract/order the registered firm has to deposit 5% Performance Security deposit of the total contract value for the contract period plus 12 months.
 - **8.Performance Security Deposit:** Successful Tenderer has to submit Performance Security deposit 5% of total contract value within 07 days after issue of work order with validity of minimum of the contract period plus 12 Month.
- 9. Validity of rates should be of minimum 120 days.
- **10.GUARANTEE/WARRANTY**: The contractor shall give guarantee/warranty of at least 06 Months in the Rain Water Harvesting Pit works along with material is used of best quality as per mentioned brand and workmanship and shall be strictly in accordance with the specifications and particulars contained/mentioned in this RFQ).
- 11. In case of supply of damaged/broken/distorted material for the Fabrication works, the same should be replaced immediately without any extra cost.
- 12. The decision of IIM Lucknow Noida Campus regarding the short listing of the agencies shall be final and binding on all concerned.
- 13.All provisions of Contract Labour (Regulation & Abolition) Act 1970 should be strictly complied with
- **14.E.S.I. & Provident Fund Obligations:** The Contractor shall follow all rules and regulations required under this Act as may be in force from time to time. All employees engaged upon the works shall be covered under these schemes and the required amounts deposited by him directly with the concerned authorities. All records in connection with the above shall be properly maintained by the Contractor and produce for scrutiny by the Institute whenever called for.
- 15. The employed workers for this contract is the SOLE responsibility of the Contractor. Any compensation for disengagement on account of death, disability of any labors(s) provided for deployment in the Institute, even if such disability manifests after the termination of the contract shall be the contractor's exclusive & sole liability and also responsibility.
- 16. The Director of the Institute shall have absolute right to impose penalty for unsatisfactory services rendered by the contractor. The decision of the Director, Indian Institute of Management

LUCKNOW regarding any disputes whatsoever arising out of the contract will be final and binding on the contractor.

17. Contractor has to maintain the Rain Water Harvesting System for next 1 year.
