### **SCOPE OF WORK:**

Supply Installation Testing and Commissioning of state of the art Audio Video facility in FB 02 Meeting Room, Chintan Block, IIM Lucknow. Camera feed is to be permanently given to OPS for video conferencing application with a splitter to feed to additional high-end P.C. (provisioned to be installed later). There will be provisioning for future fixed High-End PC in the room and a switching facility should be provided to switch between High-End PC, Guest Laptop, Display OPS, and camera input. The selection should take place manually as well as through a common controller. Camera should be linked with MIC for Auto Camera movement as per active Mic. Room size is approximately 8100x10150mm, seating capacity of up to 30 persons. There will be one Chairman and 14 delegates mic, 98" Display panel with OPS, DSP, HDMI splitter for switching the input and USB 'C' to HDMI converter, etc. with all required cables/wires/connector/converter, etc. to complete the Audio Video System of the meeting room. The conference system should be compatible with Zoom, M.S. team, Webex etc. conferencing applications. The complete system will carry 3 years comprehensive onsite warranty. Work to be done in coordination with the Civil & Electrical Contractors. All cables etc. to be concealed, which will be either placed inside the pre-laid conduits/pipes or if new conduiting is required then the same has to be informed well within the time to the civil and electrical contractor. Such work to be executed in coordination between both contractors. The successful bidder/contractor will be required to supply, install, test, commission and hand over after the successful integration of items mentioned in ANNEXURE-A1 with 03 years' onsite comprehensive warranty on the entire setup from the date of handing over.

- 1. For better understanding, the bidders are free to visit the actual site on any working days with prior intimation of 24 hrs (email id: <u>purchase@iiml.ac.in</u>, <u>project@iiml.ac.in</u>)
- 2. The successful bidder/contractor will have to supply the equipment and integrate all the equipment.
- 3. The details of the equipment that the successful bidder should supply, install, test, commission and hand over after successful integration with 03 years' onsite warranty are given in Annexure-A.

The scope of work also includes the following:

- **1.** Period for Completion of SITC for the above equipment: 30 days from the date of issue of the work order.
- 2. Cables and connectors should be of standard brand (acceptable to the Technical evaluation team) and compatible with the solution proposed by the vendor. In addition to this, if any other product is required for integration of the above equipment and for the proper functionality of the equipment supplied and to ensure the desired scope is completed in all respects, the successful bidder has to supply the same without any additional cost.
- **3.** The equipment shall be supplied, installed, tested, commissioned and handed over after successful integration with a 03-years onsite warranty from the date of handing over.
- **4.** The successful bidder/contractor has to ensure the smooth installation of the equipment at our site and has to supply all necessary products and carry out integration and installation without any additional cost.
- **5.** The cost towards cables and connectors required for interconnection/integration of the supplied equipment shall be included in the quoted cost.
- **6.** Contractor will have to work in coordination with the Civil & Electrical Contractor to avoid any confusion/ miscommunication and to proper work is completed without much dismantling/ rework etc.
- **7.** All the work related to the proper installation, functioning & integration of the systems shall be carried out by the contractor. Before handing over the final product i.e., integration of all equipment supplied against this tender, Transportation, Storage, safety and security of the supplied material, issuance of road permit, any tax, etc. shall be the sole responsibility of the contractor.
- **8.** Comprehensive warranty will include rectification/replacement of all the defective components/ items during the warranty period. All the arrangements for keeping the configured equipment functional shall be the sole responsibility of the contractor.
- **9.** After completion of the proposed work, clearances of all temporary work/materials shall be the sole responsibility of the contractor and this shall be removed immediately after the completion of the work is completed.
- **10.** All the non-functional part /materials/ items/ replaced during the comprehensive warranty/ maintenance period shall be the property of the contractor.
- **11.** After proper installation, testing and integration, the commissioning of the system shall be carried out by contractor in presence of concerned officer. The Contractor is required to submit all Warranty/ Guarantee card being provided by the OEM, Relevant operation manual etc. after completion of the Work. However, primarily, the successful bidder will be responsible for any repair/replacement during the warranty period. Any complaint made shall be attended within 24 hrs and if any major replacement is required then the same has to be made by the contractor at his own cost (including transportation etc.) within 7 days or as Approved by the competent Authority. After completion of the works the Contractor is required to give training

for operating and rectifying some of minor problems which usually occurs and can be rectified without Touching any Hardware. Contractor will give the user manual, manufacturer test certificate etc. as Applicable.

12. Agreement: The successful bidder/contractor will be required to execute an agreement on non-judicial stamp paper of Rs.100/- (cost to be borne by the contractor) within 10 days from the date of issue of the work order/ LOI.

# ELIGIBILITY CRITERIA

The eligible bidders must fulfil the following criteria/conditions and submit documentary evidence in support of the same:

- **1.** The letter of Authorization/Distributorship from the OEM on letterhead for the offered equipment (Interactive Display, Camera, Projector, Sound System, Amplifier, etc.) mentioning the aforesaid NIT number.
- **2.** Registration Number of the bidder firm along with the GST No. and the PAN number allotted by the concerned authorities.
- **3.** CA certificate with UDIN for an average annual turnover of Rs. 15 Lakh in the last 3 years (2021-22, 2022-23 & 2023-24).
- **4.** Experience: The bidder must have experience of any executing similar work within last 3 years from the last date for submission of bids at any IIT/IIM or equivalent. The term Similar nature may include the supply of any equipment (Projectors, Display Screens, Amplifier, Interactive panel, DSP, Central Audio controller, sound system with mics and Speakers etc.). The work order value shall meet one of the following conditions:
  - (a) One executed/completed work order issued in the last 3 years of not less than 80% of the estimated bid value. <u>OR</u>
  - **(b)** Two executed/completed work orders issued in the last 3 years of not less than 60% of the estimated bid value <u>OR</u>
  - (c) Three executed/completed work orders issued in the last 3 years of not less than 40% of the estimated bid value
- 5. Non-blacklisting declarations as per <u>ANNEXURES-C</u> of this NIT
- **6.** The Make-in-India (MII) content for this work must not be less than 20% of the estimated bid value/ quoted rate (whichever is higher). Declaration in this regard, as per Rule -144 (xi) of General Financial Rules-2017 and for declaring the Make-in-India content (for whole work) to be submitted by the bidder as per <u>ANNEXURES-D</u> of this NIT.
- **7.** The Bidder will have to upload the service center contact details, customer care number, etc., and service center address. The service center for major offered items shall be in Lucknow.
- **8.** The Bidder will have to upload an Escalation matrix in case the complaint is not attended timely other if there is any issue related to the service.

# DISQUALIFICATION

The proposal is liable to be disqualified in the following cases:

- **1.** Proposal not submitted in accordance with this document
- **2.** During the validity of the proposal, or its extended period, if any, the bidder increases his quoted prices.
- **3.** The proposal is received in incomplete format.
- **4.** The proposal is not accompanied by all requisite documents.
- **5.** Any Conditional tender will be rejected. If any condition mentioned by the Bidder is missed while qualifying the bidder and later after the award of the work, the bidder insists on highlighting that condition then in that case also the Bid can be canceled even after the award of the work and the bidder will have no claim in that case.
- **6.** Information submitted in the tender proposal is found to be misrepresented, incorrect or false, accidentally, unwittingly or otherwise, at any time during the processing of the contract (no matter at what stage) or during the tenure of the contract including the extension period if any.
- **7.** EMD/ Certificate in support of exemption from EMD is not submitted.

**8.** If the rates are disclosed in the Technical Bid, the bidder will be technically disqualified.

# **GUIDELINES FOR BIDDERS**

- 1. Definitions
  - a) The "IIM Lucknow" means Indian Institute of Management Lucknow.
  - **b)** "Bidder" means the individual or agency who participates in this tender and submits its bid. Work Order means the order placed after the issue of a letter of intent by the IIML to the agency signed.
  - c) "Successful bidder" means the bidder whom the contract is awarded.
  - **d)** The Contract Price means consideration payable to the agency under the work order for the full and proper performance of its contractual obligations.
- 2. The Bidders who have downloaded the tender document shall not tamper/modify the tender form including the downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited.
- 3. Bidders are advised to visit E-procure portal regularly till the closing date for submission of tender for any Corrigendum/Addendum/Amendment.
- 4. All the correspondence regarding this tender shall be on email (<u>purchase@iiml.ac.in /</u> <u>project@iiml.ac.in</u>) only.
- 5. The details of terms and conditions are being given in the Tender document. The bidder has to fill all necessary details as per the tender document and enclose documents in support of its claims.
- 6. All filled bids are to be uploaded on the above website on or before the date & time mentioned above. Manual bids will not be accepted.
- 7. Only those bidders, whose technical bids are complete in all respects, will be considered for evaluation. Financial Bids of only those bidders will be opened, whose technical bids qualify as per evaluation criteria prescribed by IIM Lucknow.
- 8. Bidders are required to submit an Earnest Money Deposit (EMD) of Rs. 50,000/-(Rupees Fifty Thousand only) as mentioned document to the below-mentioned account.

- 9. Performance Security Deposit: On the issue of the work order, the bidder shall Deposit Performance Security amounting to 05% of the contract value in the form of DD/FD/BG from any scheduled bank in favor of 'Indian Institute of Management Lucknow' payable at Lucknow. The validity of FDR/ BG shall be equal or more than the period of the contract plus 60 days. This Security Deposit may, at the option of the IIM Lucknow be forfeited in the event of the contractor's failure to fulfill any of the obligations under the contract/agreement. The security deposit shall be refunded by IIM Lucknow to the contractor after 60 days of the expiry or termination of the contract. The security deposit shall not carry any interest.
- 10. Any effort by the bidder to influence any IIML Official regarding the tendering process may result in the rejection of his bid. EMD will be forfeited in such case.
- 11. Pricing: While quoting the rates, the bidder shall read the full tender document and the following parameters:

- **a)** Quote price as per the BOQ (uploaded on the portal). Don't disclose the price/rates in your technical bid.
- **b)** The prices are to be quoted on individual item rather than the total package.
- **c)** Quote only for the product meeting the specification as per the tender document. No changes in the configuration or deviation from the tender document will be permitted.
- **d)** Need not suggest any alternative product or different configuration in the same product.
- 12. All erasures, cuttings and alterations made must be attested by the authorized person while filling the tender document. Over-writing of figures is not permitted.
- 13. If any discrepancy/misprint is noticed / specification or BOQ, it should be clarified from the Institute before quoting the rate.
- 14. Authorization Certificate to be submitted in case the Tender is being signed by any person other than the Proprietor/ owner/ Chairman of the Firm.
- 15. IIML's Right to Terminate the Process: IIML may terminate the Tender process at any time and without assigning any reason. IIML makes no commitments, express or implied, that this process will result in a business transaction with anyone. This Tender does not constitute an offer by IIML. The bidder's participation in this process may result in IIML selecting the bidder to engage in further discussions and negotiations toward the execution of a contract if necessary. The commencement of such negotiations does not, however, signify a commitment by IIML to execute a contract or to continue negotiations. IIML may terminate negotiations at any time without assigning any reason.

### **GENERAL TERMS & CONDITIONS**

- **1.** Procurement Rights: IIML Reserves the right to conclude the purchase with the entire or partial bill of material as mentioned in the price schedule.
- **2.** Variation in scope of works: Variation in quantity items may increase or decrease as per requirement of IIM Lucknow.
- **3.** IIM Lucknow reserves the right not to accept the lowest tender or not to assign any reason for rejection of any or all the tenders. IIM Lucknow reserves the right for accepting the whole or any part of the tenders and decision in the matter shall be final and binding.
- **4.** Any failure on the part of the Bidder to observe the prescribed procedure and any attempt to canvass for the work will prejudice his/her tender. Tenders/rates quoted in other than the prescribed proforma are liable to be rejected.
- **5.** The submission of tender will bind the Bidder to acceptance of all conditions specified herein and in addition to the conditions of the contract.
- **6.** The successful bidder will depute a technically qualified executive to coordinate the job with the IIM Lucknow team.
- **7.** If the bidder withdraws his bid during the period of bid validity, the EMD shall be forfeited and the firm may be blacklisted.
- **8.** IIM Lucknow reserves the right to accept or reject any or all the offers fully or partly without assigning any reasons.
- **9.** The successful bidder shall not sublet, transfer or assign the contract or any part thereof. In the event of the contractor contravening this condition, in addition to forfeiture of Performance security, the successful bidder can be blacklisted by IIM Lucknow.
- **10.** While the workers of the successful bidder perform their duties (Scope of Work), it is to be ensured by successful bidder that no damage to any immovable or movable property is inflicted, and he will compensate to IIM Lucknow for any damages to such properties.

- **11.** All the material used for the work shall be of the approved. IIM, Lucknow reserves the right to check the materials brought for as per scope of works & at any time and reject them, if not found suitable.
- **12.** The tender shall be opened & evaluated by the tender committee and the successful Bidder shall be informed.
- **13.** If any of the document submitted by the Bidder is found fake, even after the acceptance of tender, the contract will be terminated for which the concerned Bidder will itself be responsible and no compensation, etc., will be paid by the IIM Lucknow. Performance Security will be forfeited on such event.
- **14.** All the documents forming part of the contract are to be taken as mutually explanatory, supplementary and complementary to each other. If there is any error, omission or discrepancy in any of them, it shall be brought to the notice of the IIM. The decision of the IIM shall be final and binding. The contractor shall execute the work accordingly.
- **15.** The successful bidder shall examine all the contract documents thoroughly including the scope, nature and magnitude of works. He has to execute in accordance with the contract documents.
- **16.** If any discrepancy occurs between the various instructions conveyed to the contractor or his authorized representative or if any misunderstanding arises between the contractor's staff and IIM's staff, the contractor shall report the matter immediately to the IIM. The decisions of IIM shall be final and binding. Moreover, no claims for losses due to discrepancies between instructions, doubts or misunderstandings shall be admissible.
- **17.** From the commencement to the completion of works, the successful bidder shall take full responsibility for the care of all works including all civil work and in case any damage or loss occurs then the successful bidder shall repair and make good the same at his own cost so that on completion of the work, the same shall be in good order in every respect in accordance with the contract and to the satisfaction of the IIM Lucknow.
- **18.** Termination: The Institute may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, reject the offer in whole or in part. Breach of contract shall include, but shall not be limited to the following;
  - **a)** The successful bidder is unable to provide service/supply of the equipment within prescribed time limit mentioned by IIML.
  - **b)** If the successful bidder fails to perform any other obligation(s) under the Contract;
  - **c)** The Institute or the Bidder goes bankrupt or goes into liquidation other than for a reconstruction or amalgamation;
  - **d)** Notwithstanding the above, the Institute may terminate/reject the offer for violation of any law, for any reason of quality of service; or for any irregularity committed by the bidder or any other like reasons. If the Contract is terminated, the Bidder shall stop providing services immediately.
- **19.** The successful bidder must abide by all the applicable labour laws/ laws of the land such as P.F., ESIC, Third-party Insurance etc.
- **20.** All communications will be sent through emails/ eProcure portal. Bidders are requested to provide their email id (s).
- **21.** Penalty for Non-Compliance:
  - (A) Before supply, installation, testing, commissioning & handing over:
    - **a)** Tenders once submitted will not be allowed to be withdrawn, altered or cancelled in part or in whole.
    - **b)** If the project/job is returned by the firm unexecuted after accepting the same, earnest money/security Deposit will be forfeited in full and job will be got executed at successful bidder's risk from some other firm. The firm is also liable to be black listed.
    - **c)** Execution of job should be of standard quality, neat and accurate according to the specifications where IIM Lucknow is satisfied. If the execution of the job is not up to the

standard, suitable deductions will be made or the entire job will be rejected, as the case may be, at the cost of the contractor.

- (B) During Warranty: During warranty and extended warranty (Comprehensive Maintenance Contact-CAMC), the successful bidder would ensure to attend the complaint registered by the Institute within 24 hours during the weekdays (Monday to Saturday) and 24 hours on other than weekdays. Failing this, a penalty of Rs. 500/-per day for the first week and Rs.1000/- per day thereafter would be imposed and will be recovered from the Security Deposit.
- **22.** Dispute Settlement & Appointment Of Arbitrator: "All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of the Tender and the resulting agreement or the breach thereof that cannot be settled by good faith and negotiations between the parties within 30 days of the commencement of negotiations shall be settled by referring the dispute to the Director, IIM Lucknow, who may either herself decide the dispute as Arbitrator or appoint some other person as Arbitrator to adjudicate the same, who shall be unconnected with IIM Lucknow. The proceedings will be governed by the provisions of the Arbitration & Conciliation Act 1996. The venue of Arbitration proceedings shall be Lucknow and the language of the Arbitration shall be English. For any dispute, which is not resolved by the Arbitrator, the courts at Lucknow alone shall have jurisdiction.
