General Terms and Conditions

Eligibility Criteria

The Bidder must submit:

- Firm Name & Address
- Firm's GSTIN
- Details regarding the provision of support during warranty.
- EMD online submission receipt copy
- Registration Certificate
- The firm must have five years of experience in similar work/services out of which a minimum of two experience in serving the Govt. organization/ PSU/ State govt.
- The firm should have a registered office in Delhi NCR, and a supporting document for the same must be submitted.
- The firm should have Grade-1 certified Engineers, from the Institution of Fire Engineers (IFE), India or NFSC.

Terms & Conditions

The Bidder must ensure:

Pricing:

- a) Quote price as per the tender document
- b) Quote the price for each of the components and also the total amount as per the tender document.
- c) Quote only for the product specified in the tender. No changes in the configuration or deviation from the tender document will be permitted.

Payment Terms:

Payment will be made only upon successful submission of the Fire & Safe Audit report, BOQ document, and preparation of the necessary documentation and meeting the prerequisites for obtaining the fire NOC from the Fire Department. No advance payment will be made.

Scope of Work

The appointed Consultant will undertake the following tasks:

1. Assessment of Fire Safety Equipment:

The consultant will conduct a thorough inspection to identify any faulty or non-compliant fire safety equipment that requires repairs, servicing, or replacement. This will ensure that the Institute is in a position to prepare the necessary documentation and meet the prerequisites for obtaining the fire NOC from the Fire Department.

2. Fire Safety Equipment Inspection

- Verification of the availability and placement of fire extinguishers, fire hydrants, hose reels, and sprinkler systems.
- Checking the operational readiness and maintenance status of fire extinguishers (CO2, ABC, Foam, etc.) in accordance with IS 15683.

- Inspection of fire alarm systems, including smoke detectors, heat detectors, and manual call points (MCPs), for functionality and coverage.
- Review of emergency lighting and exit signage for adequacy and visibility as per NBC 2016.

3. Comprehensive Fire Safety Audit at IIML- NC :

The consultant will carry out a comprehensive audit of the entire campus and all its buildings, including but not limited to:

- I. Fire hydrant lines with Fire Hydrant Chambers (FHC),
- II. Four fire pumps, including a diesel engine pump,
- III. Three fire alarm/addressable systems with associated loops and detection devices,
- IV. Six Non-Return Valves (NRVs),
- V. Pressure gauges,
- VI. Sprinklers and water branch lines,
- VII. Ensuring the fire alarm system is fully operational and meets all legal and safety standards.
- VIII. If any point is missed in Sr. No.1-7.

4. Fire Risk Assessment

- Identification of potential fire hazards in various areas of the campus, including:
 - Classrooms
 - Hostels
 - Faculty residences
 - Basements
 - Kitchens and pantry areas
- Assessment of high-risk zones such as electrical rooms, server rooms, and storage areas for fire hazards like overloaded circuits, improper cable management, and flammable materials.
- Evaluation of the adequacy of escape routes, emergency exits, and assembly points.

5. Deliverables

- **Comprehensive Fire Safety Audit Report:**
Upon completion of the audit, the consultant will provide a detailed Fire Safety Audit Report, which will outline the findings, the necessary remedial actions, and recommendations to bring the fire safety systems into full compliance with the regulations considering as below:
 - Detailed observations and findings, categorized by risk level (High/Medium/Low).
 - Actionable recommendations to mitigate identified fire risks.
- **Preparation of Estimate/Bill of Quantities:**
The consultant will also prepare and submit a detailed estimate or bill of quantities for the work required to repair, replace, or upgrade fire safety systems as identified during the audit. This will include cost estimates for all necessary repairs, replacements, or installations to ensure compliance.

6. Security Deposit

The successful bidder will be required to deposit a Security Deposit amounting to 5% of the Purchase Order value in the name of the IIM Lucknow Noida Campus.

By consent of the parties, the jurisdiction of all other courts is excluded and the courts at Lucknow alone shall have jurisdiction. The language of the Arbitration shall be English and the venue of the Arbitration proceedings shall be Lucknow.
